



## **General Terms and Conditions for the Circus Arts Summer Camp 2026 (hereinafter “Camp”)**

### **1. Scope**

These terms and conditions apply to the Circus Arts Summer Camp organized by TALENT ACADEMY Europa-Park as well as to all related services provided by TALENT ACADEMY and/or Europa-Park. The Camp offers young people the opportunity to explore and experience a variety of circus disciplines. Under the guidance of experienced circus instructors and artists (hereinafter “Coaches”), participants will be trained in aerial acrobatics, acrobatics, balancing, juggling, and pantomime. The program aims to foster personal growth, creativity, and self-confidence in a supportive environment.

### **2. Participation**

The Camp will take place from August 3 to August 5, 2026, daily from 10:00 a.m. to 4:00 p.m. (subject to change). Eligible participants are children and adolescents aged 8 to 16. There will likely be four groups with a maximum of 10 participants each, divided into beginner and advanced levels. Participation includes workshops as well as lunch, snacks in the morning and afternoon, and beverages.

### **3. Registration**

- (1) Registration must be completed online via the Europa-Park ticket shop and must be filled out truthfully.
- (2) The registration deadline is July 15, 2026. If no spots are available before this date, registration will no longer be possible.
- (3) The contract becomes binding upon receipt of the registration confirmation.

### **4. Cancellation of the Camp**

In the event of illness or other unforeseeable, unavoidable circumstances, TALENT ACADEMY reserves the right to cancel the Camp or individual groups at short notice. In this case, participants will receive a refund of payments already made or be offered an alternative date. In the event of non-participation by a participant—whether due to fault or not—the fee according to Section 5 remains payable. No refund will be issued.

### **5. Payment Terms**

- (1) The participation fee is €260 per participant.
- (2) By registering for the Camp, you agree to pay the total amount due. This amount will be invoiced immediately after registration and is payable without delay.
- (3) If cancellation occurs later than six weeks before the start of the event, the fee cannot be refunded.

### **6. Course Implementation**

The design of the workshops, the selection of training rooms, and the selection of Coaches are the responsibility of TALENT ACADEMY. All Coaches are professionally trained instructors of TALENT ACADEMY.

### **7. Clothing**

Special clothing is required for some courses. Details will be provided prior to the Camp.

### **8. Intellectual Property**

Parts of the Camp, in particular choreographies and other course content, are intellectual property. Sharing them with non-participants or third parties is not permitted. Violations will be prosecuted.

### **9. Usage Rights**

- (1) Photography, video recording, filming, and audio or visual recordings within the premises of TALENT ACADEMY are only permitted with our written consent.
- (2) We reserve the right to take photos and/or audio recordings of courses and participants and to publish them (including for promotional purposes). Where required, consent will be obtained. No compensation will be provided.

## 10. Use of Facilities - Europa-Park

- (1) Smoking is prohibited in all our premises.
- (2) Smartphones must be switched off during all ongoing workshops.

## 11. Liability

- (1) No liability is assumed for valuables.
- (2) In cases of slight negligence, we are only liable for breaches of essential contractual obligations (cardinal obligations), including those of our vicarious agents, limited in amount to foreseeable, typical contractual damages at the time of contract conclusion, as well as for personal injury and in accordance with the Product Liability Act. Otherwise, pre-contractual, contractual, and non-contractual liability is limited to intent and gross negligence.
- (3) Participants must have valid health insurance coverage.

## 12. Invalidation of Individual Provisions

Should one or more of the above provisions be or become invalid, the validity of the remaining provisions shall remain unaffected. The parties undertake to replace the invalid provision with one that comes as close as possible to the intended economic purpose of the original provision.
